## Terms and Conditions:

- Must Participate in the Stock Order Program to participate in the monthly orders.
- Dealers who do not participate in the Stock Program will have a standard 20% discount on parts.
- Dealers who participate in the program will have an earned parts discount of 25% through October 1, 2026.
- \*\*Dealers who participate in Phase 1 of our Fall WG EOP qualify for a 25% discount on WG & parts orders through October 1, 2026.
- \*\*Dealers who participate in Phase 2 of our Fall WG EOP qualify for a 25% discount on WG & parts orders through April 1, 2026.
- Parts Stock Order Program to be used in conjunction with most current published price book at the time of order entry.
- Invoices Due Net 30 Days.
- Products will be shipped at the discretion of Art's Way
- Any holds may result in a loss of discounts/free freight.
- Account must be current to be eligible for Stock Order Program.
- Art's Way Manufacturing Co., Inc. may change or cancel this program at any time without notice.
- Returns or canceled orders that change dealers discount level will result in misc. charges back to dealer.
